Terms of contract:

I. Course start

I will receive the course documents with the information for course access (activation) at the start of the course. I can start the course on the date of my choice. I have noted my personal starting date in the field provided.

For the online course MPO, the registration must be received by Malik International 4 working days before the desired start date.

II. Cancellation / Postponement

- (1) The contract is concluded on the day of written registration. The minimum duration of the contract is identical to the standard period of study. At the end of this period, it can be terminated at any time with a notice period of 6 weeks. Services rendered up to the end of the notice period will not be refunded.
- (2) The MPO can be extended for a fee. The processing fee for a two-month extension is 150 EUR, for five months 250 EUR. A minimum processing fee of 150 EUR applies for each further extension.
- (3) Malik International has the right to cancel or postpone planned courses and seminars in case of insufficient participation. It is then obliged to refund any fees already paid. The student has no further claims.

III. Other provisions

- (1) The participant agrees that his/her personal data may be stored for the purpose of processing the event.
- (2) The materials provided to the participant are for personal use only. All rights are reserved by Malik International, unless otherwise agreed. The reproduction or use of the contents for commercial purposes is prohibited.
- (3) The participant is aware that the use of Internet services will incur additional costs (telephone charges and access to the Internet) over and above the course price.
